3. That both the husband and wife Xxxxxxxxxxxx, Mohali. But due to temperamental issues between both the petitioners, both the petitioners have been living separately Since Xxxxxxx and since then have never resided together.
4. That with the intervention of respectables the issues stand resolved between both the petitioners and both the petitioners have decided that both the parties to the petition no longer want to live together as Husband and wife and wants to Part ways from each other through mutual Divorce for good.
5. - iii. and all other claims including any share in property of self or parents of each other.

B. Mode of Payment:

C. Stridhan, Properties, Car and Gold Items

All the claims Qua the stridhan, properties and gold items of both the parties against each other has been settled and after signing of this compromise both the parties shall not initiate any proceedings before any court of law or authority against each other (including parents of each other) qua the the stridhan, properties and gold items. However the following gold items are left in the custody of 2nd party which shall be handed over to the 1st party at the time of recording of 2nd motion. **The items are:**

D. Child Expense

Upon signing this Compromise Deed, both parties shall jointly file a Divorce Petition under Section 13-B HMA as per these terms. Both parties shall appear and cooperate at the time of recording of their statements.

F. Withdrawal of Pending Cases

Before the recording of the Second Motion under Section 13-B HMA: Both parties shall withdraw all civil/criminal cases filed by them against each other (If any pending) and undertake not to file any litigation on the same cause of action in future.

G. Non-Interference

Both parties shall not interfere in each other's personal, professional and social life henceforth.

H. Finality of Settlement

The total amount of Rs. _____ shall constitute full and final alimony, compensation, maintenance of the First Party.

*After fulfilment of above said compromise, neither party shall have any claim regarding:

- i. movable/immovable property belonging to self/parents of either party,
- ii. maintenance,
- iii. alimony,
- iv. past grievances,
- v. domestic violence,
- vi. dowry disputes,
- vii. or any monetary, civil, or criminal claims.

*After receiving the entire settled amount, the First Party shall not claim any further maintenance/alimony/dues from the Second Party for herself.

I. Breach of Compromise

If either party violates or resiles from this compromise, the aggrieved party shall be free to take appropriate legal action as per law.

7. That the decision for mutual Divorce has been made by both the parties with mutual consent and without and coercion or external pressure on either party.
8. That the petition is not presented in collusion. That there are no chances of cohabitation between both the Parties. There has not been any unnecessary or improper delay in filing this petition.
9. There is no other ground why the relief should not be granted.
10. That both the Petitioner's submit that this Hon'ble Court has jurisdiction to entertain the instant petition as the petitioner No.1 and Petitioner No.2 have **lastly resided together as Husband & wife at XXXXXXXXXXXX Mohali.**

COMPROMISE AGREEMENT / SETTLEMENT DEED

This Compromise Agreement ("Agreement") is executed on **22.12.2025**, at Mohali.

BETWEEN

XXXXXX D/o Sh. XXXXX, W/o Sh. XXXXXX R/o XXXXXXX, Chandigarh.

hereinafter referred to as the **"First Party" (Wife)**,

AND

XXXXXX, Son of XXXXXXX, Resident of XXXXXXX Mohali, hereinafter referred to as the **"Second Party" (Husband)**.

(The First Party and Second Party are hereinafter collectively referred to as the **"Parties"**.)

WHEREAS

- A. The Parties were married according to Hindu rites and ceremonies and are governed by the provisions of the Hindu Marriage Act, 1955.
- B. Due to matrimonial differences, the Parties have been living separately and have decided to amicably resolve all their disputes by mutual consent.
- C. The Parties have voluntarily arrived at this settlement without any force, coercion, or undue influence.

NOW, THEREFORE, in consideration of the mutual promises and undertakings, the Parties agree as follows:

A. SETTLEMENT AMOUNT

1. The Second Party shall pay a total sum of **Rs.** _____ to the First Party towards **full and final settlement** of:
 - o past, present, and future maintenance of the First Party;
 - o permanent alimony of the First Party; and
 - o all other claims whatsoever, including any claim in the movable or immovable property of the Second Party or his parents, and vice-versa.

B. MODE OF PAYMENT

1. **Rs.** _____ shall be paid by the Second Party to the First Party at the time of recording of the **First Motion** under Section 13-B of the Hindu Marriage Act, 1955.
2. The remaining _____ shall be paid by the Second Party to the First Party at the time of recording of the **Second Motion** under Section 13-B of the Hindu Marriage Act, 1955.

C. STRIDHAN, PROPERTIES, CAR AND GOLD ITEMS

1. All claims relating to **stridhan, properties, and gold items** of both Parties

against each other stand fully settled.

2. After execution of this Agreement, neither Party nor their respective parents shall initiate any civil or criminal proceedings against each other in respect of stridhan, properties, or gold items.
3. However, the following gold items presently lying in the custody of the Second Party along with a car shall be handed over to the First Party at the time of recording of the **Second Motion**:

D. CHILD EXPENSES

1. The Parties have one child, ~~XXXXXX~~, aged about ___ **years**, born on _____.
2. The child shall be free to reside with either parent as per his own choice or custody shall remain with _____
3. All education expenses of the child shall be borne exclusively by the _____

E. DIVORCE PETITION UNDER SECTION 13-B HMA

1. Upon execution of this Agreement, the Parties shall jointly file a petition for divorce by mutual consent under **Section 13-B of the Hindu Marriage Act, 1955**, strictly in accordance with the terms of this settlement.
2. Both Parties shall appear before the competent court and cooperate fully at the time of recording their statements for both the First and Second Motions.

F. WITHDRAWAL OF PENDING CASES

1. Prior to the recording of the **Second Motion**, both Parties shall withdraw all civil and/or criminal cases, if any, filed against each other.
2. Both Parties undertake that they shall not file any litigation against each other in the future on the same cause of action.

G. NON-INTERFERENCE

Both Parties undertake that they shall not interfere in each other's personal, professional, or social life in any manner whatsoever hereafter.

H. FINALITY OF SETTLEMENT

1. The total settlement amount of **Rs.** _____ shall constitute **full and final alimony, maintenance, and compensation** payable to the First Party.
2. After fulfilment of the terms of this Agreement, neither Party shall have any claim whatsoever against the other with respect to:
 - o movable or immovable property of either Party or their parents;
 - o maintenance or alimony;
 - o past or present grievances;

- domestic violence;
 - dowry or stridhan disputes; or
 - any monetary, civil, or criminal claims.
3. After receipt of the entire settled amount, the First Party shall not claim any further maintenance, alimony, or dues from the Second Party at any stage in the future.

I. BREACH OF COMPROMISE

In the event either Party violates or resiles from the terms of this Agreement, the aggrieved Party shall be at liberty to take appropriate legal action in accordance with law.

J. VOLUNTARY EXECUTION

This Agreement has been read, understood, and voluntarily signed by both Parties in full possession of their senses and without any pressure or coercion.
